- Co-ed teams are allowed, will be played in the boys bracket

When & Where:

- Saturday March 7, 2020
- Teams report to Eureka High School
- Registration will begin at 8:00 a.m in EHS Cafeteria
- Games will start at 8:30 a.m. in EHS Gym

Cost:

- The cost for each 4 player team is \$60. (You can have up to 5 players, but that will be an extra \$10)
- Please send registration form and money to **Eureka High School by February 21, 2020**
- Cost includes three game minimum and t-shirts for every participant. Checks made payable to EHS
- T-shirts **are not guaranteed** for late registration
- No Refunds

Rules:

- All games are played to 21 baskets, by ones; a 2-point line will be used. A team must win by two, or the first team to 25 points wins.
- 5th -8th grade games will have a referee. 9th- 12th grade will call their own fouls; but there will be a court monitor provided on each court in case of disputes and to keep score.
- There is a change of possession after each basket made.
- Technical fouls are given for intentional fouls. Continual intentional fouling or misconduct will result in player or team dismissal.

Important Information:

- Each team is guaranteed three games.
- Awards will be given to first place teams of each category
- Team captain must check in his/her team before every game.
- Each team must have a team color and each player must wear the same color.
- Each team must provide its own water and towels.
- There is no smoking or alcohol on participating campuses. If seen smoking or with alcohol, you will be asked to leave.
- Concessions and parent hospitality room will be available throughout the day.
